



## Terms of contract for electronic publications on the document server

### 1. **Registration and online provision**

The author grants the Staats- und Universitätsbibliothek Bremen (SuUB Bremen) the non-exclusive (simple) right to free electronic publication on the Internet and to archive on its document server. All other rights for the exploitation of the work remain with the author. Within the scope of public provision, users are entitled to download, store or print documents for private use (§ 53 UrhG). If a free license has been chosen by the author (e.g. Creative Commons), the rights and conditions of use associated with this license apply. Once a license has been granted, it cannot be changed retroactively. The registration does not constitute a legally binding claim to online availability. SuUB Bremen reserves the right to check the fulfilment of the technical and formal requirements.

### 2. **Metadata**

In the online registration, the author provides information (including an abstract) to describe the form and content of his/her own document.

### 3. **Third Party Rights**

The publisher declares that the publication of the document and each of its components, e.g. in the case of cumulative dissertation publications, does not violate any third-party rights. The publishing party indemnifies SuUB Bremen from any third party claims. SuUB Bremen is entitled to block access to a publication if there is justified evidence of a violation of the rights of third parties. In such a case SuUB Bremen will inform the publisher of the blockage.

### 4. **Transfer to the German National Library**

SuUB Bremen is permitted to make the electronic version of the document available to the German National Library (DNB) within the scope of the compulsory levy according to the German National Library Act (DNBG). In addition, SuUB Bremen is permitted to make the documents available to specialist libraries with a national collection mandate, such as the special subject collection libraries or the specialist information services of the funding programmes of the German Research Foundation. These institutions are granted the same rights as SuUB Bremen

### 5. **Long-term archiving and transformation into other formats**

SuUB Bremen is granted the right to store the document in a long-term archive and, if required (e.g. migration, accessibility, improved accessibility, indexing), to transfer it to other electronic and physical formats and to use it according to (1.).

### 6. **Dissertations, habilitations and exam theses**

If the document is a final thesis (dissertation, habilitation, master's, bachelor's, diploma thesis, etc.), the person publishing it assures that the files supplied correspond to the version approved by the department and that the responsible institution or supervisor has expressly agreed to the publication of the document.

The author accepts the declaration of consent for final papers or e-dissertations/E-Habilitations and submits them signed to SuUB Bremen. If the text contains a curriculum vitae or other personal data, the person publishing the text agrees that the text will be stored automatically and made publicly available.

### 7. **Withdrawal of the transfer of rights**

The author may only recall the rights granted under No. 1 by referring to § 42 UrhG (work no longer corresponds to the author's conviction). SuUB Bremen is entitled to charge the publishing party for the expenses incurred by this.
